  - 2. Each candidate choosing Category 2, Category 3 or Category 4 of the Contribution of Personal Funds Declaration must actually deposit an amount of personal funds at least equal to the applicable Category minimum in his or her campaign fund within 10 days of filing the Contribution of Personal Funds Declaration, and file a Form 808, Deposit of Personal Funds Declaration, within 24 hours hereafter.
